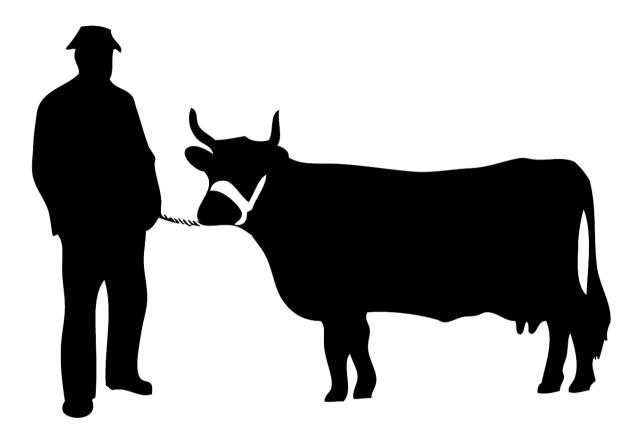

PRESIDENTS REPORT: Betsy Smith

Betsy asked the members if there was any discussion on the Presidents report.

THAT the President's report as published on the website and in the AGM Booklet be accepted.

Moved by Betsy Smith/Julie Rush.....carried unanimously

Council Reports: Betsy Smith

Betsy briefly went over the council reports and moved they be accepted

THAT the Council reports and the report of Office Holders off Council as published on the website and in the AGM Booklet be taken as read.

Moved by Betsy Smith/John Walstcarried unanimously

THAT the Council Reports and the report of Office Holders off Council be adopted Betsy Smith/Grant Keymer.....carried unanimously

TREASURERS REPORT: Grant Keymer

Grant talked about the healthy state of the society bank account. He talked about his proposal that existing members have a free membership for the next financial year.

Tony Cutten asked how much the net loss would be. Grant said this would be about \$17,500.

Grant also talked about the cut in interest rates from Westpac bank.

Steve Snelgar asked about putting surplus funds towards encouraging members to attend the AGM. Grant explained this was discussed at last years AGM and there was a survey sent to members for suggestions and it concluded that the members that responded did not want to use money on the AGM as only a small proportion of the members attend.

John Walst pointed out this is a remit so it will be discussed then. Betsy agreed and asked members to think about this before the remits are discussed.

John Walst asked about making a term deposit at another bank with a higher interest rate. Grant talked about the effort required for the return which is very little extra compared to the current investment at Westpac.

THAT the Financial Accounts and Auditors Report for year ending March 31, 2016 as attached and circulated at the meeting be accepted. Moved by Grant Keymer/Robyn Snelgar.....carried unanimously

Jillian Walst proposed a vote of thanks to Grant for his work as treasurer. Everyone thanked Grant for his work on the finances

THAT the Treasurers report as published on the website and in the AGM Booklet be accepted. Moved by Grant Keymer/Tony Cuttencarried unanimously

NEW COUNCIL:

Betsy Smith thanked Lucy for joining council.

Betsy informed the members that it is a society requirement to have complaints officers and that Di Burgess has resigned so we need a replacement Complaints Officer preferably South Island based.

Betsy talked about the RAS proposal promoting Youth in the show ring Robyn asked Julie if she was interested in being co-opted to council as the Promotions portfolio holder which she accepted

THAT Julie Rush be co-opted and accepted to the role of Promotions Officer on council with and Youth Encouragement being included in the role. Robyn Snelgar/Maureen Pettersson......carried unanimously

Betsy thanked Julie for volunteering to take on this position.

SNOWLINE & TUROA YOUTH TROPHIES

Betsy announced the winners of the 2 Showing Trophies She talked about the trophies and how they came about and they criteria for entry for these 2 awards. The winner of the Snowline Trophy is Julie & Alex Bromham of Te Kuiti with 29 points. The runners up were Daniel Ward & Jane Rist.

Betsy accepted the trophy on Julie & Alex's behalf.

The winner of the Turoa Trophy is Arjan Pederson with 89 points. He has been showing Dexters since he was about 5 years old.

Grant accepted this on Arjan's behalf and will take the trophy to him. Betsy talked about the Turoa Youth Trophy while presenting it.

Meeting adjourned at 10.00am for morning tea

REMITS

Remit 1 - Membership Fees - Proposed by council

THAT membership renewal fees be waived for the 2016/2017 financial year with fees applicable to new members remaining unchanged.

Rationale – The society currently has surplus funds. This has arisen due to the greatly reduced costs of printing the Dispatch over the past 2 years. Council sees this is an equitable way of returning surplus funds to all current members.

There was a lot of discussion on alternatives to using society funds.

John Walst proposed an amendment to the remit

THAT remit 1 be amended to read -

THAT membership fees for new members be waived with fees applicable to existing members remaining unchanged.

John Walst/Tony Cutten..... For -3, against 19.....lost

John Walst replied to this and said that this seemed to be a good idea based on his experience with new members. This is a good way to promote the breed.

John Blanchard said that the current \$50 fee is very little paying a fee shows a commitment to the breed. Lindsey Benbow suggested 2 years for the price of one.

Trudy said that we have a very cheap membership. The Herefords charge \$150 per year plus dam fees Mary Howard said that by making this available to new members only would take a long time to reduce surplus funds.

Grant said this would only benefit new members

Marion Mangnall felt that many new members only last a couple of years so would not be of much benefit. John Walst replied with comments on the declining membership so this remit may help by giving them the benefit of the society.

Robyn talked about the national decline in membership of all breeds of animals and the national decline of people coming and going on lifestyle blocks.

Maureen Pettersson proposed another amendment to the remit

THAT remit 1 be amended to read **THAT** all subs be reduced by \$10.00 for the next financial year Maureen Pettersson/Julie Rush

For 11, against 8, abstentions 1.....carried

The new remit was voted on **THAT** all subs be reduced by \$10.00 for the next financial year Maureen Pettersson/Julie Rush.....carried by majority For 11 proxies 16, against 7, abstentions 2

Maureen said that all members will get something out of this including junior and associate members. John Blanchard said \$50 is very cheap and thought funds could be spent elsewhere.

Lucy Raisbeck asked why surplus funds is a problem. Grant said we are a non-profit organization so we need to do something with some of the funds. John Blanchard said to spend more on promotions and could we budget for it.

Grant said there is \$400.00 per year for each area group which doesn't get spent.

Julie Rush suggested more money be spent on prize money.

Note - Remit 1a will not be necessary if Remit 1 is passed – this was not voted on as an amendment was passed for membership

Remit 1a – Membership Fees - Proposed by council*THAT* membership fees remain the same for the next year.Rationale - There is no need to make any change.

Rationale - There is no need to make any change
For 21 proxies 9, against 0.....carried unanimously

Remit 3 - Transfer Fees

THAT Transfer fees remain the same for the next year Rationale - There is no need to make any change For 20 proxies 14, against 1 proxy.....carried by majority

Remit 4 - Membership Categories

THAT Regulation 2.1 - Membership be updated as follows
2.1 Categories of Membership:
Membership shall be divided into the following categories:
(A) MEMBERS WITH VOTING RIGHTS: Limited to residents of New Zealand who belong to one of the following categories

Full membership, 1 vote per stud - \$50.00

Rationale – To ensure a quorum is met at the AGM by allowing all current Full Members voting rights.

Trudy asked why a stud with 2 members get 2 votes and a stud with 1 person get 1 vote. There general discussion was that we need the votes and it is a practical way of making sure the quorum is met after the effort taken to attend the AGM.

The remit was amended to remove the \$ amount from the remit

THAT remit 4 be amended to read - THAT Regulation 2.1 - Membership be updated as follows

2.1 Categories of Membership:

Membership shall be divided into the following categories:

Remit 5 – Amendment of Regulation 9.7

THAT Regulation 9.7

9.7 In the event of a non-member selling previously registered Dexters to a DCSNZ full paid member, these cattle are able to be transferred to that person with all the original rights of registered Dexters. The cattle will be inspected to confirm their identity by sighting at least one but preferably both ID tags registered with the DCSNZ – Nait tag and/or DCSNZ brass tag. To be confirmed by photograph..

Any registration forms are to be returned to Herd Registrar, **along with payment for transfer.** Any calves born whilst cow in non-member ownership cannot be registered. For any cow/heifer purchased in-calf, proof will be required that the sire is a registered Dexter bull and is owned by a current financial member of DCSNZ.

Be amended to read as follows -

9.7 In the event of a non-member selling previously registered Dexters to a DCSNZ full paid member, these cattle are able to be transferred to that person with all the original rights of registered Dexters. The cattle will be inspected to confirm their identity by sighting at least one but preferably both ID tags registered with the DCSNZ – Nait tag and/or DCSNZ brass tag. To be confirmed by photograph.

Any registration forms are to be returned to Herd Registrar..

Any calves born whilst cow in non-member ownership cannot be registered. For any cow/heifer in-calf, proof will be required that the sire is a registered Dexter bull and is owned by a current financial member of DCSNZ.

Rational – The society has no jurisdiction over non-members to pay the transfer fee. The buyer (member) has not created the situation therefore should not asked to pay a fee.

For 20, proxies 15, against 0.....carried unanimously

Remit 6 – Members Selling to Non-members

THAT Regulation **9 Transfer of Ownership of Cattle** have a section added to cover the fees due for members selling to non-members. The regulation being –

9.8 In the event of a member selling to a non-member no transfer fee will be payable. The seller must sign, scan/email or post the green form to the Herd Registrar within 30 days of sale.

Rationale – The process has been unclear and transfer fees have frequently been unpaid in these circumstances.

For 20 proxies 15, against 0.....carried unanimously

The budget could not be confirmed until the remits were finalized due to membership remit Grant made amendments to the budget due the remits that were passed. This was presented to the members showing all figures that were changed. The members recorded these changes in their copies of the AGM booklet.

THAT the amended budget for 2016-2017 period be accepted Grant Keymer/Helen Blanchard.....carried unanimously

GENERAL BUSINESS:

Deregistering Animals

Marion Mangnall talked about this in Remits - Deregistering animals.

The merits of cattle that are sold on and how they should be represented in the herd book was discussed. If an owner decides that an animal is not suitable for future breeding due to poor conformation these animals are often sold on as unregistered (on hold). Currently such animals can be brought back into the herd back with Nait or dna.

Terminology of the records was discussed – Not suitable for breeding, commercial This needs to be covered in a remit next year.

SI Complaints Officer

This was covered in the elections section of the meeting with John Blanchard being co-opted as the South Island representative.

South Island Breed Show

This was discussed earlier but there was a recap and further discussion on the future of the show. This show has been struggling due to poor support in recent years.

Betsy informed the members of how the show is organized and how the host A&P show is chosen.

Betsy suggested that the show be put on hold as there has been no suggested host A&P show for the next year. If a member would like to suggest and/or continue this can be reinstated at any time.

Change of date for AGM Weekend.

The AGM weekend being change to Queens Birthday weekend was briefly discussed. The members were all happy to keep things as they are.

Use of surplus society funds.

John Walst suggested that a historical data base be kept for data that may be of interest to members. Research articles kept for member interest. Grant talked about documents being stored in a central data base.

Jillian Walst suggested more promo material in the local magazines.

Marion Corbett suggested leasing a trailer for shows being funded by the society.

Truck hire was also suggested.

2017 AGM

Council had previously discussed a possible option for the venue for next and year and put their suggestion to the members.

The members in attendance were happy with this suggestion.

The suggested venue for 18th AGM & Conference on 10 June, 2017 will be held at Hamilton (North Island).

PRESIDENT'S REPORT

Council met 3 times over the past year, as has been the pattern for several years now. These F2F (face to face) meetings have been the main vehicle by which Council members have discussed Society matters. For the rest of the year, Council's main method of communication is by email. As has also been the case for several years, the F2F meetings were held at the home of Robyn & Steve Snelgar, thus reducing the accommodation cost for the Society. I would like to take this opportunity to thank Robyn & Steve for hosting Council F2F meetings for those 3 weekends.

In April, Council trialed a meeting via conference. call Thanks go to Grant Keymer for co-ordinating this. Due to the success of the April meeting, Council has agreed to meet via conference call again in place of the July F2F meeting. It is hoped that other members may consider joining Council if the majority of meetings are conducted in this way in future.

I would like to thank fellow Council members and office-holders for all the hard work you do on behalf of the Society throughout the year. These voluntary positions are very important to the running of the Society. Recognition must also go to those members who promote the Dexter breed in a variety of ways, both locally and nationally.

Unfortunately, Lucy Raisbeck, who joined Council last year, has resigned due to family and work commitments. This means that there is currently no South Island representation on Council, which is not an ideal situation. As members will have noted, Council has circulated messages via the Dispatch and the DCSNZ Face Book page, inviting the nomination of a South Island member. This is a matter for the membership to rectify.

The DCSNZ Face Book page has become increasingly popular as a means of communication for members, Area Reps and Council. Advertisements for cattle (both for sale and wanted to buy) can be posted on the page. This is a closed FB group; if you are not a member and wish to join, make a request to Grant Keymer via the FB page.

The Website Market Place is no longer functioning; it now has a link to the DCSNZ Facebook page for those wishing to advertise stock.

It is pleasing to note that the Society's finances continue to remain favorable. Grant will give more details in his financial report.

As you will have read in the May Dispatch, the Society has a new internet domain: dextercattle.nz. Thanks go to Grant for securing this for us when it became available. The existing domains will also remain functional for now.

There have recently been a number of new members joining the Society, which is a pleasing trend. Membership numbers are included in Maureen's report. Julie Rush has taken on the new 'Youth Co-ordinator' portfolio which she is in the process of developing. This initiative fills a gap in the Society's functions and is in line with the RAS focus of encouraging youth into the show ring.

Over the last few months, 2 national bodies have asked Cherry Oak Stud to provide Dexters for their events: the FMG Waikato/BOP Young Farmer of the Year Regional Final and the Dairy NZ and Fonterra sponsored Waikato Exscite Interactive Exhibition 'Milk Matters: Towards Sustainable Farming", aimed at 7- 12yr olds and their families. Cherry Oak Stud was also asked to provide 2 quiet weaner heifers for a 'Farmyard' display at the recent Waikato Show (a combined Waikato Winter Show and Waikato Home Show). These 3 occasions provided ideal opportunities to promote Dexters to the wider public, in particular to audiences who wouldn't usually have the chance to learn about the breed.

Massey University, Palmerston North, informed Council in April that BD1&2 testing (for chondrodysplasia in Dexters) is now available. The previous DNA/sire verification submission form available on the DCSNZ website has been updated to include a request for BD testing.

I wish to remind members of one particular DCSNZ regulation ie that brass tags MUST BE INSERTED IN ANIMALS' EARS. The lack of brass tags (or matching NAIT tags) has created additional expense for members who wish to have previously registered Dexters brought back into the Herd Book, as they have had to pay for a DNA test prior to sire verification of the animal.

Council has recently discussed a possible future remit requiring female Dexters to be DNA profiled prior to registration. This would bring heifer registrations in line with that for bulls, thus increasing the integrity of the Herd Registry. It would also take the Society one step closer to enabling future FPV (full parent verification).

Both the online cattle registration and cattle transfer forms are being accessed by a significant number of members. Paper copies may still be sent to Mary Howard (Herd Registrar Assistant) for processing. It is vital also that members inform Tony Houlbrooke (Herd Registrar) when animals need their status updated in the Registry – either because they're deceased/culled or have been sold to a non-member. It is a regulatory responsibility of members to inform the Herd Registrar of changes so that the accuracy of the Registry is maintained. Animals sold to non- members, as well as those whose status has not been notified, are coded 'ON HOLD' in the Herd Registry. This indicates that the animal is not 'active' in the Registry and is therefore not counted in the tally of registered stock.

I hope all members who attend this year's Conference & AGM in Hamilton have a most enjoyable weekend.

WEBSITE REPORT 2017

Our new web server hosted by NZ company NET24 has been up and running for just over 6 months now with excellent performance and reliability. The utilisation from month to month has been fairly consistent, with a slight reduction over the December/January period before rebounding to record levels in February/March. Usage by overseas visitors is about 63% vs. 37% for domestic visitors meaning that our site is proving to be a valuable resource for people not only within NZ but around the world.

On March 30th, the internet address dextercattle.nz became available after its 'Reserved' status lapsed. This provides the shortest possible address for members to reach our website and I've had my eye on it since it was announced in September 2014. Dextercattle.nz is now owned by DCSNZ and will become our preferred web address over time as printed materials are updated. The existing dexter-cattle.co.nz address will continue to operate in parallel with the new one for many years or perhaps indefinitely as it has been our web address since 2002.

SHOWING AND JUDGING REPORT 2017

As has been the case for the past few years, some A&P Shows last season had good numbers of Dexter entries, some provided a separate Dexter Section and at other shows Dexters were paraded with other breeds.

Well done to those members who helped with shows in any way and to those who exhibited Dexters last season, with a special welcome to 'newbies' to the show ring. It was especially pleasing to see some new youth handlers exhibiting Dexters.

Exhibitors at the NIBS held at Rotorua were very fortunate to benefit from judge, Carl Botha's, excellent commentary on each animal in the ring. This was a very well supported event, with 15 animals entered by 5 members.

The Waikato and Tauranga Shows were also very well supported, with entries of 9 and 14 Dexters respectively.

Smaller numbers of Dexters were entered in shows in Northland, Hawkes Bay, Manawatu and Wairarapa.

The 2016/17 NIBS will be held at Morrinsville.

Unfortunately the SIBS was not held last season, due to a continued lack of members exhibiting Dexters in the South Island.

There were very few Dexter entries at the Royal A&P Show, which was held at Hastings again last season. It would be good to see an increase in entries at this Show in October 2017.

A&P Shows, Show results, past trophy winners and a judges' list can all be found on the DCSNZ website. A Dexter judges' list is also in the RAS website.

The NIBS & SIBS shields and DCSNZ Royal Show Trophy are each presented at their respective shows. In addition to these, the Society has 2 show trophies which are awarded at the AGM, on points accrued over the season. The winners of the Snowline Trophy and Turoa Youth Trophy will be announced at this Conference & AGM.

HERD REGISTRAR'S REPORT 2017

• Keeping the register in shape

After the "purge the register" operation which removed a large number of animals that were long since dead there were 1735 live animals at that point (May 2015). Twelve months on the number of live animals (May 2016) was 1624. Currently (May 2017) there are 1450 live animals showing. So we are appear to be keeping the registry trimmed with culls being regularly removed.

We are continuing to remind members to advise us when they do cull animals.

• Online versus standard mail

The use of online registration continues to be the favoured way to register animals – this has increased over the last 12 months so that possibly 75% are registered in this manner. The online transfer system has emerged also this year which is used often. There are some challenges with this. To mimic the paper system we needed to have involvement of both seller and buyer verifying the transaction. This required that both fill out the online form. Inevitably one or other is tardy doing this. The question has been asked – do we need both to do this – would it be satisfactory to just have the seller fill in the form? We do now have an online form for reporting culls as well.

A reminder also that it is an acceptable practise to scan and send transfers or culls attached to emails – thus saving the postage cost and time lag.

We are continuing to maintain the physical records – it is surprising how often they need to be accessed to verify when and how something was actioned in the past.

Payment is often a headache. This is amplified with more online processing. A majority pay promptly as they tick the paid online option, but some take a long while. Also locating the appropriate payment from the bank can be challenging. The simplest identifiers are Membership number & reason – eg Mem 123, 2x transfers

• Brass Tags & Identification of animals

Brass tags continue to be issued with each registered animal though it is discouraging that so few find their way into ears. This means we need to be vigilant in gathering secondary physical identification. NAIT tags are in the ears of every animal and we do encourage those numbers to be included with registration. Many members are doing this now.

In the cases where tags are not conclusive in providing ID of an animal occasionally DNA profiling can assist. We have had quite a number of cases this year which have been difficult – where lapsed members have sold animals and these having no brass tags. So begins the process of checking for other tags, or then a DNA test. Also the DNA test may not be an option as there may not be a profile of the sire to match to.

?

• DNA test arrangements

The changed arrangements for DNA profiling have been in place for 18 months now. Members are taking responsibility to send in tail hairs directly and action their own DNA tests. By and large this is working well. Massey was suggested as being the recommended provider (with UQ & UC Davis as other alternatives). Almost all profiling this year was done through Massey.

Registrations of bulls continue to require a certain amount of work from the registrar – locating a profile of the sire often being needed – and there are still sires out there who were profiled under Genemark's G3 (SNP) profiling. These cannot be converted and must be re-profiled with tail hairs and a satellite test.

• Full parent verification

Discussions are in progress for the possible requirement that all registrations be parent verified. This has rather large implications. Matches would have to be done to both sire and dam. This is underway in the US. They have started this by initially requiring that all females be profiled (bulls already are). In particular the time requirements of the Herd registrar would be extended greatly. It may be attainable for a retired person, or with an extra assistant registrar!

REMITS 2017

Remit 1 – Membership Fees

Proposed by Council

THAT membership fees remain at \$40.

Rationale – The society still has surplus funds so this is a way to give something further back to the members.

Remit 2 – Transfer fees for Member purchasing from Non-member

Proposed by council

THAT Reg 9.7 be updated to include the following: 'the DCSNZ full paid member who purchases the stock is to pay the transfer fee'

9.7 In the event of a non-member selling previously registered Dexters to a DCSNZ full paid member, these cattle are able to be transferred to that person with all the original rights of registered Dexters. The cattle will be inspected to confirm their identity by sighting at least one but preferably both ID tags registered with the DCSNZ – Nait tag and/or DCSNZ brass tag. To be confirmed by photograph.

Any registration forms are to be returned to Herd Registrar.

Any calves born whilst cow in non-member ownership cannot be registered. For any cow/heifer incalf, proof will be required that the sire is a registered Dexter bull and is owned by a current financial member of DCSNZ.

Rationale: To clarify payment of the transfer fee in line with information on the website.

Remit 3 - MEMBERSHIP CATEGORIES – Proposed by Trudy Robertson #978, seconded by Michelle Goodwin #1114

THAT Regulation 2.1 – Membership be updated as follows

2.1 Categories of Membership:

Membership shall be divided into the following categories:

MEMBERS WITH VOTING RIGHTS: Limited to residents of New Zealand who belong to one of the following categories

Full membership, 1 vote per adult member to a maximum of 2 per stud

Be changed to

Full Membership, 1 vote per Stud

Rational – To have voting rights fair for all studs within the Society no matter how many people are involved in each stud. No other Cattle Society or Association within New Zealand allows anymore than 1 vote per stud.

Remit 4 - AMENDMENT OF CONSTITUTION 4.4 CATEGORIES – Proposed by Trudy Robertson #978, seconded by Michelle Goodwin #1114

THAT Constitution 4.4 be updated to as follows

4.4 The quorum for a General Meeting will be twenty (20) voting members.

Be changed to

4.4 A quorum for a General Meeting shall be ten percent (10%) of the membership of the Society or fifteen (15) voting members all personally present or by proxy whichever shall be the lesser.

Rational – To ensure a quorum is more easily met at the AGM.

TREASURER'S REPORT 2017

Financial Report for the year ended 31/3/17

- * Accumulated Funds are \$37,502 vs. \$35,800 budgeted
- * Current year deficit is \$5,799 vs. \$7,500 budgeted

This happy situation is largely due to the 46 new members who have joined this financial year -- the largest number since 2012-13. Also, careful management of costs, and some promotional budgets being underspent.

We have sufficient postage stamps in stock to cover at least 18 months of Dispatch issues. This should mean a smaller deficit next year; however the Brochures and Breeder's Handbook will soon need to be reprinted, resulting in some erosion of next year's savings.

Term deposits total \$24,500 which will allow us to leave membership subs at \$40 per year and continue running modest deficits for at least the next 3 years. Thereafter, subs may have to return to \$50 but 2020 is a long way off, so it's difficult say with any certainty.

Due to personal circumstances, we have not yet received the audited accounts as we normally would have at this time of year. Hence the audited accounts are not included in this booklet. However, the complete accounts will be provided at the AGM in June, and will be published online as soon as they are available.

PROPOSED BUDGET FOR 2017-18

Basically the same as actual expenditure 2016-17 except for:

1) Breeders handbook needs to be reprinted. 500 copies costing approx. \$1500.

2) We don't need to buy any stamps this year due to large remaining stock.

3) Brochures need to be reprinted. 1000 copies costing approx. \$300.

4) AGM is expected to be about \$1500 more expensive than last year due to increased numbers attending, a more costly bus trip and meal costs being a bit more expensive. The final amount may be less than initially thought depending on the generosity of members at the auction.

DEFICIT for 2016-17 was \$5800

PROJECTED DEFICIT for 2017-18 is also \$5800 approx.
